The chief told the council that this was not the case, he resigned on his own, the council did not persuade him in any way. Vice-Mayor Munoz stated that she felt the chief has done a good job and wanted it to be on record that he was not terminated nor asked to resign.

Mayor Smith moved to accept the resignation of Chief of Police Louie Tartaglia. Vice-Mayor Munoz seconded the motion and the motion carried. 6-0
