Council Member Lagunas moved to approve the above meeting minutes as recorded. Council Lopez seconded the motion and the motion carried. 5-0

The Mayor and Council Will Listen to Comments, But May Take Any One of the Following
Actions (1) Respond to Criticism, (2) Request That Staff Investigate and Report on the Matter
and (3) Request that the Matter be Scheduled on a Future Agenda. SPEAKERS SHALL BE
LIMITED TO THREE (3) MINUTES.

Ms. Nancy Almanza addressed the council concerning vehicles driving fast in front of her house on Rock Drive. She asked if speed bumps can be installed. Mayor Smith asked if extra patrol can be scheduled for this area. Ms. Almanza said that she did not know if extra patrol would help. Interim Chief Thompson said that he would make sure that there is extra patrol scheduled for this area. General Superintendent Cruz recommended that the extra patrol be tried first because this road is not a highly traveled road and he would not want to install speed bumps at this time.

Council Member Ruiz mentioned that opening ceremonies for Little League is scheduled to start on April 21st.

CALL TO THE PUBLIC CONT.

Mrs. Vicki O'Brien to address the council concerning the dog issues in the town

Mrs. O'Brien asked the council when they were planning on hiring an animal control officer. She wanted to know who she should call to report dogs that are running at large. She said she has called

the police department but the officer talk to the owner of the dog but it still continues. She also mentioned that there are ten dogs on her street and they bark continuously day and night. She read the sections in the town code where it says that dogs must be contained or on a leash. Mayor Smith told Mrs. O'Brien that the town is not planning on hiring an animal control officer at this time but is planning on an agreement with either the Town of Winkelman or the Town of Kearny. Interim Chief Thompson told Mrs. O'Brien that she should keep calling in the complaints to the police department so that it will be documented. He said that the officers are not trained to pick up dogs and that they cannot place a dog in the police vehicle because if urine or feces get into the wiring it will cause damage. He will look into possibly citing the owner into court.

Consideration to reimburse town employees for AFLAC Insurance Premiums that were payroll deducted but was never submitted to AFLAC in the \$16,050.65 which will be distributed to affected employees

Accountant Williams told the council that the town will be receiving money in May from property taxes and the money should be able to be paid to the employees at that time. Accountant Williams said that she had researched the information and come within a couple hundred of what the Town's Auditor had estimated. Council Member Lopez moved to approve the reimbursement to Town Employees. Council Member Lagunas seconded the motion and the motion carried. 5-0

Consideration to pay or not pay an outstanding AT&T bill in the amount of 20,320.76
Accountant Williams told the council that when the new phone systems were installed AT&T was not notified. Town Clerk called AT&T to terminate and the town was stilled billed for another two or three months. Town Attorney advised the town to argue this bill. Council Member Lagunas moved to negotiate the bill. Council Member Garcia seconded the motion and the motion carried. 5-0

Fire Chief Silva arrived at 6:02 p.m.

- a) Police & Animal Control, Written Report Interim Chief Thompson read the police report and magistrate report to the council. Council Member Ruiz asked Interim Chief Thompson how is first day was. He responded that it was very quiet and he was able to meet one on one with some of the officers. He is planning a staff meeting the next day with all the officers.
- b) Fire, Written Report Fire Chief Silva stated that he is contacting vendors on site at ASARCO and local businesses for donations for the Fourth of July activities.

He told the council that the library, senior center and town hall are all having problems with the phones. Council Member Garcia asked questions on some on the checks that were issued on the claims that are to be approved.
- g) Public Works, Oral Report Reported on an issue at treatment plant, had to order parts to get the pumps going again. Did a roof repair job at the club house. He reported that he will need to purchase about seven golf cart batteries. Council Member Ruiz asked if the Little League Field was ready for Little League. General Superintendent said that it was ready to go. He also reported that he is working on getting the swimming pool ready. He said that they installed the pump.
