# <u>Kaleb Thomas, Eagle Scout to present a proposal of renovation of the Veteran Memorial</u> located at Garms Park

Kaleb Thomas addressed the council on this project he would like to do for the Veteran Memorial. He told the council that he would like to paint the Veteran Memorial, place pavers to make a walkway from the road to the memorial; place a bench and a flag pole. Mayor Smith told Kaleb that the town has been planning on asking someone from the area to re-do the memorial and maybe they would be able to work together on the project. Mayor Smith asked General Superintendent Cruz if he wanted to add anything to what Kaleb is planning on doing. General Superintend Cruz mentioned that he would like to keep the same design that is on the memorial, it was originally painted by someone in town and this person no longer can see well enough to re-do it. Kaleb said that he liked the design that is painted on the memorial and plans on keeping the same design. He said that he welcomes anyone that may want to help with this project. He told the council that this project will cost \$3,000 to complete. This item was not on the agenda for approval but the council was asked to sign a form so that the organization can ask for donations for the project. Council Member Dean said that the town can also ask for donations. This will be place on next month's agenda for approval.

<u>Re-organization of police department/Authorization for temporary assignment of sergeant with no increase in pay</u>

Chief Villar told the council that she asked for this to be placed on the agenda to ask that Officer Marquez be given the title of Sergeant with no increase in pay. Mayor Smith mentioned that he has some reservations due to some issues in the past, nothing major. Chief Villar told the council that she has met with the officer and he was told of her expectations. She reported that he has been doing an exceptional job. Officer Marquez has agreed to this temporary assignment with no additional pay for twelve months; if the council approves this request. He understand that at the end of twelve months, he will be evaluated and at that time the council can decide if they feel it is beneficial to keep him as sergeant with an increase in pay. ### Discussion and possible action on a salary increase for Officer Smith

Vice-Mayor Munoz moved to approve an increase in salary in the amount of \$23.66 for Officer Smith, effective 8-21-18. Council Member Cruz seconded the motion and the motion carried.6-0

# <u>Discussion and possible action allowing the reimbursement of mileage when using personal vehicles, due to town vehicles needing repairs</u>

### DEPARTMENTAL REVIEW/REPORTS

Police & Animal Control, Written Report- Chief Villar reported that her department has been working on the case where Rachel Apodaca has started structures on fire in Hayden, Winkelman and Kearny. The owner of the structure in Hayden refuses to cooperate and will not press charges. Pinal County is working on the one in Kearny. They also have been working with the family of the little girl that was taken by her biological mother and they believe the mother and daughter are in Mexico. The mother did not have custody of the daughter.

Public Works, Oral Report – General Superintendent Cruz reported on the cattle situation. He asked that the police officer help them in keeping the cattle out of the golf course area. He has spoken with Rodriguez, the owner of the cattle and he knows that Rodriguez is making attempts at trying to keep the cattle out but it does not seem to be working. There was discussion on possible citing into the magistrate court. Police Officer Nehrmeyer reported that the Town of Wickenburg has a model ordinance and he will request a copy for the town.
