<u>Discussion and possible action to approve the hiring of Robert Youdelman effective October 30, 2018</u>

Chief Villar told the council that the ad for hiring a police officer was still posted on the Town of Hayden's Website and AZ Post Website. She is requesting the approval to hire Robert Youdelman. Mr. Youdelman is currently an officer for the Town of Mammoth. She hired him when she was chief for the Town of Mammoth and he did an outstanding job.
