CALL TO ORDER

The meeting was called to order at 5:30 p.m.

MAGISTRATE DEPARTMENT/Discussion and possible action on accepting a retirement letter submitted by Judge Larry Bravo effective December 31, 2018

Vice-Mayor Bobby Smith moved to approve the retirement letter submitted by Judge Bravo Effective December 31, 2018, Council Member Lagunas second the motion and the motion carried 5-0

MAGISTRATE DEPARTMENT/Consideration to Approve Appointment of Judge Adeline Martinez as Pro Tempore for Hayden Magistrate Court, Effective January 1, 2019

Mayor Dean Hetrick advised the council that a forty dollar per case compensation fee is not mention on the line item, but it should be consider as part of the motion. Council member Thomas Lagunas questioned if a permanent magistrate would be hired, and if Judge Adeline Martinez would be considered. Mayor Dean Hetrick stated that Judge Larry Bravo is still interested in the position and would like to be considered for reappointment. The mayor explained to the council that there is a process to rehiring an employee after they retire through the Arizona State Retirement, and that the Town Clerk Laura Romero is gathering the information for the council.
