Vice-Mayor Smith moved to approve the above meeting minutes as recorded. Council Member Cruz seconded the motion and the motion carried. 4-0

Mrs. Diana Acuna Lopez to request waiving the club house and ramada fees for September 14th and 15th Fiesta. Money raised will be given for Little League Field lights-

Mrs. Lopez explained to the council that she would like to give back to the Town of Hayden. She had heard that the Little League Field needed new lights and she decided to plan a September Fiesta to raise money to help purchase new lights. If there is money left over, she would like to purchase paint to paint some of the buildings in Hayden. Her next event will be Dia De Los Muertos. She would like to have a parade and people can pay to have a loved one picture hung at the cemetery on Dia De Los Muertos. The money she makes from this event will also be used to paint buildings. She is asking that the town waive the fees for renting the club house and ramadas. She will need the club house for the two days because she will be selling alcohol inside of the club house. The Catholic Church has a golf tournament scheduled for September 14th but she has met with them and hopefully they can work together and bring in more people for these events. Town Clerk asked if she would be purchasing insurance for this event. Chief Villar said that she had received information on the Tulip Programs and will help get the insurance through this company. She is also working with Mrs. Lopez to obtain a liquor license. Some of the activities will be a dance, pinatas for adults and one for children, horseshoe tournament, corn hole tournament, kickball tournament and tamale contest. Vice-Mayor Smith moved to approve waiving the fees for the club house and ramadas but a rental agreement still needs to be signed and insurance need to be purchased. Council Member Cruz seconded the motion and the motion carried. 4-0

<u>Discussion and possible action on possibly not entering an IGA with Gila County for the Summer Work Program</u>

This was placed on the agenda again due to the budget situation at this time. Vice-Mayor Smith said that the program is only for six weeks and is a good program for kids and he felt that we would be able to pay these kids for six weeks and then get reimbursed at the end of the program. Vice-Mayor Bobby Smith moved to not change the previous vote and to participate in this IGA. Council Member Cruz seconded the motion and the motion carried. 4-0

The Fair Housing Proclamation was read aloud by Town Attorney Cooper.

Discussion and possible action on Fourth of July Celebration and setting a budget Vice-Mayor Smith asked about a donation letter. Town Clerk Romero told him that the letter will be ready the following day. He said the he would pick them up and distribute them but felt that it is best to approve an amount at this time and then hopefully we will get some donations. Vice-Mayor Smith moved to approve \$5,000 for fireworks and \$500 for food. Council Member Cruz seconded the motion and the motion carried. 4-0
