7. <u>Discussion and possible action on approving a liquor license for Diana Acuna Lopez for the September Fiestas</u>

Mayor Hetrick asked Mrs. Lopez if insurance had been purchased for this event and she said that she has purchased insurance and added the Town of Hayden to the policy. She told the council that she needed to get their approval so the application can be submitted to the liquor board and she can continue planning for the fiesta. Council Member Lagunas moved to approve a liquor license for the September Fiestas. Vice-Mayor Smith seconded the motion and the motion carried. 5-0

8. <u>Discussion and possible action on approving financial assistance to help fund the Town of Kearny Ambulance Service</u>

Mayor Hetrick moved to table this item because the Town of Kearny will be having further discussions at their council meeting on other alternatives. Council Member Lagunas seconded the motion and the motion carried. 5-0

Mayor Hetrick mentioned that Gila County Library has started to set up the temporary library in the senior center. Council Member Lagunas moved to approve the IGA between the Town of Hayden and Gila County Library. Council Member Cruz seconded the motion and the motion carried. 5-0

10. Discussion and possible action on setting a rate for notary service.

Mayor Hetrick told the council that the town has not had a notary for several years and we now have a notary at the police department and a rate needs to be set. He mentioned that he thought the rate should be \$2.00 per stamp; which is what he was informed that the Town of Winkelman charged per stamp. Financial Director Williams told the council since the town is increasing rates, if the council wanted to charge more for this service, she felt the fee could possibly be as much as \$10 per stamp Mayor Hetrick said he still felt \$2.00 would be a fair amount and it is being increased from the previous fee of .75 per stamp. Council Member Lopez moved to implement a \$2.00 fee per notary stamp. Council Member Cruz seconded the motion and the motion carried. 5-0

11. <u>Discussion and possible action on purchasing 14 tires for police vehicles from Earthmovers in the amount of \$2,200.49</u>

Sergeant Tarango told the council three of the Expeditions needs four tires and the truck needs two tires. Finance Director Williams asked that in the future if they can arrange a schedule so that there are not so many being purchased at one time.
