The regular council meeting was called to order at 5:30 p.m.

Council Member Lagunas moved to approve the above minutes as recorded. Vice-Mayor Smith seconded the motion and the motion carried. 6-0

CALL TO THE PUBLIC/Citizens Wanting to Address the Council on Any Non-Agenda Item The Mayor and Council Will Listen to Comments, But May Take Any One of the Following Actions (1) Respond to Criticism, (2) Request That Staff Investigate and Report on the Matter and (3) Request that the Matter be Scheduled on a Future Agenda. Nellie Acton told the council that she had read in the paper that the town might dis-incorporate. If the town does dis-incorporate where would the customers pay their bills. Mayor Hetrick advised Ms. Acton that if the town dis-incorporates this would be worked out with Gila County. Ms. Acton asked if Gila County would provide police protection because in the past there were issues with this. Mayor Hetrick told Ms. Acton that all these things would be worked out if the town disincorporates but at this time the council is not saying for sure that this will happen.

Vice-Mayor Smith made a motion to move the regular council meetings from the third Monday to the third Tuesday for January and February. Council Member R. Lopez seconded the motion and the motion carried. 6-0

Discussion and possible action accepting utility payment arrangements for strikers if a written request with names is submitted by a union official/time frame for extensions

Vice-Mayor Smith moved to not change the policy. Council Member E. Lopez seconded the motion and the motion carried. 6-0

<u>Discussion and possible action on planning a Christmas Luncheon for town employees</u> Council Member Lagunas moved to approve a Christmas Luncheon for town employees, not to exceed \$200. Council Member Cruz seconded the motion and the motion carried. 6-0

<u>Discussion and possible action on a community wide action plan due to extenuating circumstances created by the Asarco strike</u>

Town Attorney Cooper told the council that he would be willing to wait on receiving a check from the town if it becomes a hardship during this time. Gila County Supervisor Woody Cline told the council that he has been in contact with Mr. Belshe from the League of Arizona Cities and Towns. They have decided to contact a finance person, Pat Walker and have her work with Hayden's Finance Director Teresa Williams to see if they can come up with a financial plan. Vice-Mayor Smith mentioned that Finance Director does an excellent job for Hayden and she has been keeping the council up to date and letting them know what needs to be cut. Supervisor Kline told the council that Ms. Walker has contacts and may be able to find out why the town's assessment has been fluctuating. Gila County Supervisor Cline told the council he feels that maybe having Teresa Williams and Pat Walker working together, they can find something to help prevent the Town of Hayden from having to dis-incorporate. Supervisor Cline asked what

time frame did we have to work with. Mayor Hetrick said approximately 14 months. Supervisor Cline told the mayor he would keep him updated by email. Mayor Hetrick asked him to copy the attorney and town clerk on the emails. Vice-Mayor Smith moved to have this item placed on next month agenda. Council Member Lagunas seconded the motion and the motion carried. 6-0

DEPARTMENTAL REVIEW/REPORTS

Police & Animal Control, Written Report – Chief Villar reported that her clerk was out of the office sick and that is why there are no reports for the council. She told the council that activity is comparable to this time last year; it is usually slower during the colder months.

Fire, No Written Report – Fire Chief Gonzales reported that everything has been quiet. Magistrate, No Written Report- Town Clerk Romero told the council that the court clerk did not submit a report, the court implemented a new program and she is in training.

Finance, Written Report

Public Works, Oral Report – General Superintendent Cruz reported on a water break. He reported that he talked with his Chris and Bob about getting their certifications. They have been having issues with pumps.

Golf, Written Report

Senior Center, Written Report – Senior Center Director Hinojos reported that the senior center served 40 meals to families that are on strike. Gila County CAP paid for the meals and they will continue to pay for lunches for strikers that want to come in and eat or pick up a lunch. She reported that she needs to take the van to Phoenix to get the seat belt fixed. Mayor/Vice-Mayor – Mayor Hetrick mentioned that he received a phone call from James Ruiz with CopperNet, he is wanting to put something together to bring before the council concerning placing miniature towers on light post. This would be beneficial for people that have internet service in the area. There will not be any cost to the town.
