Mayor Hetrick informed the council that the Public Hearing had already been approved at last month's meeting. Council Member R. Lopez moved to approve the Regular Council Meeting as recorded. Vice-Mayor Smith seconded the motion and the motion carried. 5-0

Interim Police Chief Dodd to introduce and give Oath of Office to Police Officer Brandon

Council Member Lagunas moved to approve the amended agreement between the Town of Hayden and Gila County Library, effective July 1, 2020. Vice-Mayor Smith seconded the motion and the motion carried. 5-0

DEPARTMENTAL REVIEW/REPORTS

Police & Animal Control, Written Report – Interim Chief Dodd reported that he has five full time police officers and four reserve officers. In the future he would like to hire one more officer so that he will be able to fill another sergeant position. He told the council that the Town of Winkelman's Mayor is interested in purchasing the last vehicle that was to be auctioned. Council Member Lagunas asked about using the GPS. Interim Chief Dodd told the council that he did not feel a need to use GPS. Finance Director Williams reported that she has not received an invoice for the GPS. She mentioned that the town had to sign a contract for the GPS. Interim Chief Dodd said if there is a contract, he will check into the process of breaking the contract.

Fire, Written Report –

Magistrate; Written Report-

Finance, Written Report – Finance Director Williams reported that there was a revision in the State Revenue Sharing and State Sales Tax in the amount of \$15,000. This will cause the budget to be decreased by this amount.

Public Works, Oral Report – Mayor Hetrick reported for General Superintendent Cruz, the work has been started for the CDBG Waterline Project, he is still trying to keep the cattle off the golf course area and parts have been ordered for pump station #3.

Golf, Written Report

Senior Center, Written Report- Senior Center Director reported that the senior center has been professionally disinfected and the employees will be returning to work tomorrow, Mr. Ramsey will be in to repair the freezer, the line from the freon was leaking and United Fire will be here on August 17th to check the fire extinguishers all buildings and vehicles.

Mayor/Vice-Mayor – Mayor Hetrick reported on Asarco Warn Act, the smelter will be closed indefinitely. He asked that the Asarco situation be placed on the next meeting agenda, giving the opportunity for ideas going forward.


The regular council meeting was adjourned by the mayor at 6:13 p.m.
