Council Member Lagunas moved to approve the above minutes as recorded. Council Member R. Lopez seconded the motion and the motion carried. 4-0

 Interim Police Chief Marquez administered the Oath Office to Police Officer Jose Tavena

8. Discussion and possible action of an Amicus Brief concerning Apache Stronghold v. U.S. et Al.,case number 21-15295, in the U.S. Court of Appeals for the Nineth Circuit

Mr. Klenk told the council that Resolution Copper is asking for the town's support for the Land Exchange to move forward. Apache Stronghold is appealing the decision in the U.S. Court of Appeals for the Nineth Circuit because it will prohibit them from practicing religious ceremonies. Mr. Klenk told the council that this property is importance to the mining industry and the economic to the local towns. There is not cost to the town for joining in Council Member R. Lopez moved to support the Amicus Brief concerning Apache Stronghold v. U.S. et Al.,case number 21-15295, in the U.S. Court of Appeals for the Nineth Circuit. Council Member Lagunas seconded the motion and the motion carried. 4-0

9. <u>Discussion and possible action on Glenn Woodland's request to obtain and place an easement</u> at E. Plaza Drive in San Pedro

Mr. Woodland is requesting an easement at E. Plaza Drive in San Pedro. He is purchasing a house in this address and it sits toward the back of the property; his neighbor has vehicles that are not operable and tires blocking the entry way to his house. If he can obtain an easement for a small piece of property owned by the town, he plans on making a horseshoe driveway and in the middle he plans on having a community garden. General Superintendent Cruz explained that the town has service lines running in this area and will need access for repairs. Mayor Hetrick said that something needs to be done in this area, possibly restrict parking. Attorney Cooper suggested Interim Police Chief, General Superintendent and himself work together to find a solution for the parking situation and the clutter allowing Mr. Woodland access to be able to get to his house. Mayor Hetrick moved to table this item until Interim Police Chief, General Superintendent and the Town Attorney gets more information. Council Member Lagunas seconded the motion and the motion carried. 4-0

10. <u>Discussion and possible action on the IGA between Town of Hayden and Town of</u> Winkelman for Police Protection

Mayor Hetrick moved to table this item until the town receives notice from the Town of Winkelman indicating if they agree with the terms of the IGA. Council Member R. Lopez seconded the motion and the motion carried. 4-0

11. <u>Discussion and possible action to approve the current Blue Cross Blue Shield Medical,</u> Principal Dental, and Avesis Vision

Council Member Lagunas moved to approve the current Blue Cross Blue Shiel Medical, Principal Dental and Avesis Vision. Council Member E. Lopez seconded the motion and the motion carried. 4-0

12. <u>Discussion and possible action on approving the Commuter Insurance for full time employees in the amount of \$6.52 per employee</u>

Council Member R. Lopez moved to approve the Commuter Insurance for full time employees. Council Member Lagunas seconded the motion and the motion carried. 4-0

13. <u>Discussion and possible action on updating policies for the police department, two quotes</u> were received one from Lexipol in the amount of \$14,000 for the initial cost and \$2,000 annual fee and Edwards & Amato in the amount of \$2,500 for the initial cost and \$2,000 annual fee. Interim Chief Marquez request going with the lower quote from Edward & Amato There were discussions on the price amounts and time frame of these payments. Mayor Hetrick moved to table this item until more information is received. Council Member Lagunas seconded the motion and the motion carried. 4-0

14. <u>Discussion and possible action on purchasing Guardian Tracking which tracks employee</u> awards and recognition, admin review use of force performance notes, training, discipline, attendance, and threshold responses in the amount of \$865 annual and \$303 implementation fee

Mayor Hetrick tabled this item until there is more information on the Police Service IGA between Town of Hayden and Town of Winkelman. Council Member R. Lopez seconded the motion and the motion carried. 4-0
