7. <u>Discussion and possible action on approving and adopting the following Resolutions</u>: Resolution No. 2021-05 (Garbage Rate Increase)

Mayor Hetrick read the title and number for Resolution No. 2021-05. Council Member Lagunas moved to approve and adopt Resolution No. 2021-05. Council Member Cruz seconded the motion and the motion carried. 5-0

Resolution No. 2021-06 (Sewer Rate Increase)

Mayor Hetrick read the title and number for Resolution No. 2021-06. Council Member Cruz moved to approve and adopt Resolution No. 2021-06. Council Member R. Lopez seconded the motion and the motion carried. 5-0

Resolution No. 2021-07 (Water Rate Increase)

Mayor Hetrick read the title and number for Resolution No. 2021-07. Council Member R. Lopez moved to approve and adopt Resolution No. 2021-07. Council Member Cruz seconded the motion and the motion carried. 5-0

Resolution No. 2021-08 (Fee Increases)

Mayor Hetrick read the title and number for Resolution No. 2021-08. Council Member Lagunas moved to approve and adopt Resolution No. 2021-08. Council Member E. Lopez seconded the motion and the motion carried. 5-0

8. <u>Discussion and possible action on determining if the position of Interim Police Chief is a salary position and not entitled to overtime compensation or is an hourly position and entitle to overtime compensation</u>

Interim Police Chief told the council the reason he had worked overtime is because at this time the department is short staffed. Attorney Cooper was asked that since the position of Chief is a salary position with no overtime and the town does not have a policy for the position of Interim Police Chief should the town pay overtime. Attorney Cooper told the council that since it is only four hours and Interim Police Chief Marques does not anticipate it happening again and if it does happen again, he will be able to work his schedule to avoid having to work overtime; he does not feel there is a problem paying him the overtime. If this does happen again then the council may want to decide if they want to allow overtime with a cap on the overtime, pay all overtime or make it a salary position with no overtime. Council Member Lagunas moved to table this item at this time. Council Member R. Lopez seconded the motion and the motion carried. 5-0

9. <u>Discussion and possible action on approving the counteroffer received from Town of</u> Winkelman for Police Services/Protection

After discussing the counteroffer received from Town of Winkelman the council decided that they would consider the \$125,000 but for a term of one year not three years. Council Member Lagunas moved to approve an IGA with the Town of Winkelman for Police Services in the amount of \$125,000 for term of one year and for a letter to be sent to Town of Winkelman stating this is the final offer. Council Member Cruz seconded the motion and the motion carried. 5-0

10. Discussion and possible action on updating policies for the police department, two quotes were received one from Lexipol in the amount of \$14,000 for the initial cost and \$2,000 annual fee and Edwards & Amato in the amount of \$2,500 for the initial cost and \$2,000 annual fee. Interim Chief Marquez request going with the lower quote from Edward & Amato Council Member Lagunas moved to approve updating policies with the lower quote of \$2,500 for the initial cost and \$2,000 annual fee from Edward & Amato. Council Member Cruz seconded the motion and the motion carried. 5-0

- a) Police & Animal Control, Written Report Interim Chief Marquez went over the police report. He informed the council that they received the active shooters vest and helmets. report

- e) Public Works, Oral Report General Superintendent Cruz told the council that he would like to get the streets sealed and Impact Asphalt quoted him a price of \$50,000. Finance Director Williams said that there is approximately \$37,000 in the Highway User Fund. Mayor Hetrick told General Superintendent to inquire what can be done with this amount. He reported that they are still dumping at the Oracle Landfill. He reported still having issues with cattle at the golf course and asked if Animal Control Officer Lagunas can help with getting cattle off golf course. Interim Chief Marquez said that Animal Control Officer should be able to help. There was some discussion on closing the gates at the cemetery. Interim Chief Marquez said that he though it had been discontinued because the other side of the cemetery is opened.
