8. <u>Discussion and possible action to approve the Copper Corridor EDC to serve as the</u> Destination Marketing Organization for the Town of Hayden

Mila Besich-Lira addressed the council on the benefits of having the Copper Corridor EDC serve as the Destination Marketing Organization for the Town of Hayden. COVID Relief monies were designated to help with tourism to help get businesses back on track. Copper Corridor EDC works with a co-op giving a 60% discount on advertising for tourism and there is local control on how monies are spent for the communities. Ms. Besich-Lira advised the council that names had to be submitted a few months ago and they were not able to reach out to all communities, however, if the Town of Hayden approves Copper Corridor EDC to serve as the Destination Marketing Organization, then next year they can offer more program opportunities to the town and there is no cost to the town. Council Member Lagunas moved to approve Copper Corridor EDC to serve as the Destination Marketing Organization for the Town of Hayden. Vice-Mayor Smith seconded the motion and the motion carried. 5-0

9. <u>Discussion and possible action on the use of the American Rescue Funds</u>

Mayor Hetrick told the council that the town is going to receive monies from the American Rescue Funds but there are five specified areas the funds can be used which includes support public health expenditures, address negative economic impacts caused by the public health emergency, replace lost public sector revenue, provide premium pay for essential workers, and invest in water, sewer, and broadband infrastructure. Financial Director Williams advised the council that the town will receive a total \$210,741.47. The town received the first half of the money in the amount of \$105,370.73 in July and the remaining half in 2023, the funding must be spent by 2026. There were discussions on the guidelines for each of the five areas. It was mentioned that most of the items did not apply to the town except possibly the essential workers, due to the short staff all employees were considered essential and needed to report to work. Council Member Lagunas moved to table this item until the next council meeting. Vice- Mayor Smith seconded the motion and the motion carried. 5-0

Police & Animal Control, Written Report – Police Officer reported they are looking into a pack of dogs coming from the Asarco area, still needs to get photos of the yards that need to be cleaned, and they had 8-9 arrest in September.
