## Mr. Angus Sallis to address the council on dog issues

Mr. Sallis told the council that a neighbor has 15 dogs and the dogs are running all over. He spoke with the owner and was told that he has asked the town to take the dogs but there is a charge and he can't afford to pay. Mr. Sallis called Gila County Animal Control and was told that they can't pick up the dogs because they are governed by the Town of Hayden's bi-laws. Police Chief Marquez told Mr. Sallis that the owner has been cited but not sure of his court date. Attorney Cooper told Mr. Sallis that he will be in court when the owner is scheduled to be in court and he will see what he can do to take care of the issue.
