8. Richard McClain and Corrine Moffat- to address the council on extending reservation for RV Space #4 until April of 2024 at the monthly rate of \$372.60 or possibly lowering monthly rate in exchange of volunteer services at Hastings Park

No one to address the Mayor and Council. Mayor Hetrick told the Council that he will give this item a couple of minutes and will come back for action.

Corrine Moffat arrived at 5:41 p.m. Mayor Hetrick asked Ms. Moffat what she is requesting from Mayor and Council.

Ms. Moffat told the Mayor and Council she is asking council to approve extending reservation for RV #4 until April 2024 paying the monthly rate of \$372.60. She stated that she can't volunteer so the request is for the monthly rate only.

Mayor asked if the town has ever approved reservations for this extended period of time? Town Clerk Laura Romero responded no. General Superintendent Gary Cruz stated that the Space Rentals were never designated for extended stays and he would like to avoid getting into any landlord tenant situation.

The Mayor asked Town Attorney Stephen Cooper for guidance and legal clarification in this matter.

Town Attorney Cooper stated the rental spaces are not subject to the Arizona Residential Mobile Home Act or the Arizona Residential Rental Act because it is government property and being a park it's exempt. Attorney Cooper told the Mayor and Council if they wish to consider doing this, there need to be some clauses to the motion.

Vice-Mayor Smith asked Ms. Moffat if they were here for the winter. Ms. Moffat stated no, that the park was recommended, and it's been quiet and they like it.

Council Member Lagunas stated that he didn't see a problem with this as long as the person reserving the space agrees to the stipulations mentioned by Attorney Cooper.

Mayor asked Attorney Cooper if he would put something in written.

Attorney Cooper said if this is the case, the Mayor and Council might consider a motion to approve the request subject to being reduced to writing by the town attorney and mayor which will outline the stipulations they discussed.

Town Clerk Laura Romero asked the Mayor and Council if this form will be used for any person requesting an extended period time.

Mayor stated that the request would still have to come before the Mayor and Council for approval that would be longer than a month and request to lock the space for that extended period of time.

Vice-Mayor Smith moved to approve the request contingent to an agreement to be drafted by the Town Attorney and signed by both parties.
